**IF THIS PERMIT IS GRANTED, I / WE AGREE TO THE FOLLOWING CONDITIONS:**

- ( 1 ) Traffic will be maintained at all times, unless permission has been granted by County Board of Commissioners to close the road.
- ( 2 ) Disturbance to road surface and shoulders will be kept at a minimum and trenches will be backfilled with gravel and tamped, so that settlement of material will be minimized. If settlement does occur, additional suitable material will be put into place and compacted at applicant's expense.
- ( 3 ) The road surface at the trench will be replaced with material of the type that was removed. The new surface will conform with the grade of the undisturbed surface.
- ( 4 ) Lights, signs, barricades and if necessary, flagman and watchmen, will be placed on the job for the protection of traffic at all times, day and night, during the time this work is being done. Instructions given by the County Engineer's Department, as to handling of traffic, will be fully complied with.

- ( 5 ) The Applicant assumes the responsibility for and will save the County harmless from any and all claims for personal injuries and property damages, and shall defend any action that might be brought due to work.
- ( 6 ) Responsibility under this permit will remain in force until a written or verbal release has been granted by the County Engineer.
- ( 7 ) Any and all tile drains or drainage structures damaged shall be replaced to their original condition.
- ( 8 ) If the proposed installation is for the purpose of transporting effluent from individual sewage disposal systems, the owner or owners of said systems do hereby agree to maintain said outlets and to comply with all regulations of the Ohio Environment Protection Agency and the Paulding County Health Department, and in doing so hereby relieve the Paulding County Engineer of any responsibility in the enforcement or maintenance of this system.
